**CIRCULAR**

Subject:- **FILLING UP OF THE POSTS OF COMMANDANT (WORKS), SECOND- IN –COMMAND ( WORKS ) & SECOND-IN-COMMAND ( ELECTRICAL ) NON MINISTERIAL (COMBATISED POST) IN BSF ON DEPUTATION BASIS**

It has been proposed to fill up the posts of Commandant (Works), Second-in-Command(Works) and Second-in-Command (Electrical), Group 'A' Gazetted, Non Ministerial (Combatised) posts in the Border Security Force on deputation basis for a period of 3 years. The eligibility conditions are as under:-
