With reference to advertisement No. PGI/RC/029/2014 dated 01.08.2014 and corrigendum and addendum dated 14.8.2014 and 10.09.2014 for the posts of Public Health Nurse, Security Guard and Medical Social Worker Grade II/Psychiatric Social Worker, the written examination for which was held on 29.03.2015. It is for the information of all candidates that the candidates whose result is shown as 'Eligible' are shortlisted for the next stage of the recruitment process. Candidates can check their eligibility or ineligibility in the link provided on the website of PGIMER i.e. www.pgimer.edu.in. The candidates are required to fill his/her roll number & date of birth in the column provided in the link for result.

All the eligible candidates are, therefore, informed that they have to apply afresh in the given application form to be downloaded from PGI website www.pgimer.edu.in and to send the same alongwith all certificates duly attested by the Gazetted Officer so as to check their eligibility for the posts of **Public Health Nurse, Security Guard and Medical Social Worker Grade II/Psychiatric Social Worker**. All column of the application form are to be filled and no column should be left blank. The applications complete in all respect and accompanied with all the certificates must reach the **Assistant Administrative Officer, Recruitment Cell, PGIMER, Sector 12, Chandigarh – 160 012 through speed post/registered post/by hand on or before 21.04.2015 (04.00 PM)**. No applications received after this date i.e. 21.04.2015 will be entertained and candidature of such applicants will be treated as cancelled. The candidates are, therefore, advised to apply as soon as possible so that their applications may reach in Recruitment Cell of PGIMER, Chandigarh well before the last date. The Institute would not be responsible for postal delay due to any reason. The envelop carrying the application alongwith testimonials must be clearly subscribed in capital letters the name of the post applied for i.e. Public Health Nurse, Security Guard and Medical Social Worker Grade II/Psychiatric Social Worker as the case may be.

On receipt of applications of the short listed 'Eligible' candidates, the scrutiny of their applications will be done to check the eligibility of the candidates by the Scrutiny Committee of the Institute. The scrutiny/eligibility will be determined as per the guidelines/detailed information notified in the advertisement and the documents submitted by the candidates. **The candidates found eligible after scrutiny would be called for the interview. The list of candidates to be called for interview will be displayed on the Institute's website at www.pgimer.edu.in.** Therefore, candidates are advised to visit PGI website www.pgimer.edu.in frequently to check their eligibility and date of the interview/personal interaction/trade test/objectivised interview etc., as the case may be. No separate interview/call letter's will be issued to the candidates.
