[I]. ELIGIBILITY CRITERIA FOR THE POST OF SENIOR RESIDENT:-

1. **Qualification:** - MBBS with Post graduate degree/DNB/Diploma or equivalent as per the Residency Scheme in the concerned specialty from a MCI recognized University/Institute. They must not have completed 03 years Senior Residency in any of the recognized institute including regular &/or ad-hoc basis.

2. **Age Limit** - As on 31.03.2015 shall be 35 years for General candidates, 40 years in case of SC/ST and 38 years in case of OBC.

3. **Pay Scale:** - Pay in Pay Band-3, Rs.15600-39100 +6600 GP with NPA + Other allowances admissible. (i.e. Rs.18750 + GP 6600+ allowances)

4. The candidate must have valid registration in Delhi Medical Council with P.G. qualification.

5. Appointment will be for a period of 89 days initially and will be extendable further after a mandatory break of one day for each 89 days up to a maximum period of 03 years on the basis of satisfactory work & conduct report from the concerned HOD and on request from the doctor concerned.

6. Appointment will be subject to Medical fitness and verification of certificates of educational qualification, age, caste internship completion and DMC registration etc.

[II] GENERAL CONDITIONS FOR RECRUITMENT:

- [1] All the eligible candidates should report to the office of the undersigned at 9.00 AM. Registration shall be done from 09.00 A.M. to 11.00 AM and Interviews shall begin at 11:30 AM.
- [2] For candidates applying for OBC category, the certificate must be issued by the Competent Authority of Govt. of NCT of Delhi.
- [3] The reservation for person with disability/ex-serviceman will be as per the Government rules.
- [4] The number of vacancies may vary.
- [5] No TA/DA will be given for appearing in the interview.
- [6] Candidates are advised to ensure that they fulfill the eligibility criteria as mentioned before appearing the interview.
- [7] Other service conditions will be applicable as per service conditions prescribed from time-to-time by the Govt. of NCT of Delhi.
- [8] Jurisdiction of Dispute - In case of any legal dispute the jurisdiction of court will be Delhi/New Delhi.

Further in case of non availability of candidates, as per the relevant scheme mentioned above, candidates may be considered in terms of provision of relaxation as per circular No. F.No.121/26/2010/H&FW/1996-2045, dated 10.06.2011 issued by Health & Family Welfare Department, Govt. of NCT of Delhi with the following relaxation:-

1. Upper age limit for eligibility for Senior Resident will be 40 years.
2. In case of non availability of fresh candidates, the candidates who have completed 3 years of Senior Residency may also be allowed under relaxed norms to appear in the interview.
3. Separate merit list would be prepared for the candidates who have completed their residency of 3 years as SR.
4. Candidates appearing under relaxed norms will be considered only after exhaustion of the merit list of the fresh candidates.
5. Further, all Residents appointed under relaxed norms will be a period of one year only.
